a **East Sussex County Council** – Problems with buses. Councillor Ratcliffe said this had not been fully resolved with the extra problem of, in the event of Whatlington Road being closed the buses go down the A.2100 leaving the children waiting at the bus stop in Whatlington Road. He has had to take the children many times to school himself. They are now taking the problems up privately with Councillor Field.

**b Defibrillator -** This has now been serviced, returned and working. The problem seems to be when it is too cold it stops working and needs to be warmed up. The Chairman did this recently by taking the Defibrillator into his home over night.

#### 5) CORRESPONDENCE

- a) Society of Local Councils They had advised increases in clerks' salary. Councillors agreed to increase salary to scale 24.
- b) East Sussex Highways.- Drains The clerk advised there have been numerous emails back and forth resulting in a site meeting on the 13<sup>th</sup> February with the clerk and a Mark Stapley, Drainage coordinator. They also spoke with the owner of Lilac Cottage. The drains have now been cleared and the Highways Steward reminded he has to keep a regular check on the drains by the village hall. The Highways have also said that they consider soil from the broken down verges as debris and leaves should be cleared by Rother District Council also verge edges could be considered but would be expensive and they may not agree to this, nor would some residents.

40 members of the public attended and the meeting raised quite a few items.

- 1- The recent stopping of turning right from the A.21 to B2089 has caused problems to residents, also no consultations on this to parish council or residents.
- 2- Lowering the speed limit from John's Cross to Ricards Lane to possibly 40mph, as now there is a roundabout at John's Cross and the school is well protected from traffic there is no need of a 20mph limit
- 3- As the village has several bends we need road calming, the road calming in Hurst Green was mentioned as their road is straight whereas ours is not
- 4- Road sign n the parish are too large for a small village.
- 5- Flooding of Marley Lane junction with the A.21 and the road having to be closed causes more traffic down Whatlington Road C.293. They did say this is being looked into.
- 6- And finally, walkways for pedestrians along Woodmans Green Road (A.21) this was discussed a few tears ago but nothing has been done.

They were asked if they walk the area before implementing changes and they said they do. We were told they would arrange a meeting in June 2023 to explain what is being proposed to be done. The clerk will contact them in May for this date.
